What is a Landman?

Landmen constitute the business side of the oil and gas and mineral exploration and production team.

Company landmen negotiate deals and trades with other companies and individuals, draft contracts (and administer their compliance), acquire leases and ensure compliance with governmental regulations.

Independent field landmen serve clients on a contract basis and are generally the industry's contact with the public as they research courthouse records to determine ownership and prepare necessary reports, locate mineral/land owners and negotiate oil and gas leases and various other agreements, obtain necessary curative documents and conduct surface inspections before drilling.

Independent land consultants serve clients on a contract basis and much effort is directed to due diligence examinations required in the purchase and sale of companies and properties.

NDPC Launches Planting for the Future Habitat Program - The North Dakota Petroleum Council (NDPC) is partnering with the Outdoor Heritage Fund (OHF), ONEOK, private landowners and wildlife groups to launch a new program dedicated to planting trees throughout North Dakota. Called "Planting for the Future," this Partnership will leverage industry, landowner and conservation resources for large tree and shrub plantings that

will help with conservation, soil preservation and habitat for deer, pheasants and other wildlife. Following planting, the trees will be monitored for up to three years to ensure successful plantings. In addition to working with landowners, Planting for the Future plans to partner with Mule Deer Foundation, Pheasants Forever and other local conservation and sportsmen groups to provide trees and shrubs for their projects.


The Partnership's original goal was to plant 55,000 trees within the next three years using OHF funds and landowner and industry contributions; however, 26 projects have already been submitted, and the program is on track to plant all 55,000 trees this spring if weather allows!

Although the program is on track to be completed within one year, the NDPC expects additional funds may be obtained to continue this program in subsequent years and welcomes support and contributions from other companies. Companies willing to get involved in the program can help in one of three ways:

- 1. Donate to the NDPC Planting for the Future program to help purchase trees or cover costs.
- Connect with one or more of the applicants directly to assist them with their project.
- 3. Organize volunteers to come out and help with the plantings.
