ACT TODAY: Watford City seeks assistance following devastating storms

A newborn baby was killed and more than two dozen people were injured when the storm moved through the Prairie View RV Park in Watford City shortly after midnight on Tuesday, July 10 according to media reports. More than 120 structures were demolished.

Many, many people have assisted so far with donations of food, clothing, lodging, but more help is needed.

McKenzie County Emergency Management officials are asking that those who wish to help donate money rather than clothing or household items. North Dakota oil and gas production hits new record

North Dakota has reached new records in both oil and gas production. May preliminary data released by the Oil and Gas Division indicates North Dakota is now producing 1,244,629 barrels of oil per day - an increase of 17,146 barrels from the last record set in December 2014.

North Dakota also continues to set record numbers for gas production reaching 2,318,754 MCF per day according to May data.

The Bakken is undisputedly a world-class resource that is providing a secure and reliable energy resource for our nation. Last week's news was a clear signal that this is the place to be. Our next challenge is to continue building infrastructure and attracting a skilled and workforce to continue growing this great resource."
