This sale includes roughly 11,561 gross and 6,869 net acres in 8 different counties. After reviewing the list of tracts, I suspect this sale will proceed more quickly than the sale held in August in Medora.

As the majority of North Dakota's Bakken producing counties are seeing at least the first well drilled we are seeing a change in land work and responsibilities. While there is still some leasing, the majority of the play has been leased and we are seeing more in the way of due diligence, curative, surface use agreements and pipeline easement work. We are also seeing fewer landmen than we did in the past. As things tend to shift in this industry, L.A.N.D. membership and A.A.P.L. membership becomes even more important.

Membership establishes contacts throughout the industry. These contacts are a valuable tool to better understand the market place and to network. I want to thank you all for your membership in L.A.N.D. and for those of you who are not yet members of A.A.P.L., I encourage you to join.

Again, thank you for allowing me to serve in this position and I look forward to seeing all of you at our upcoming meeting and at the State sale the following day.


